**NOTICE OF MOTION**

**SOLID WASTE MANAGEMENT WITHIN THE COUNTY**

Mr Speaker, Sir,

I beg to **GIVE** Notice of the following Motion;

**AWARE** that **Article 42** of the Constitution provides that every person has a right to a clean and healthy environment, which includes the right to have the environment protected for their benefit for present and future generation through legislative and other measures;

**ACKNOWLEDGING** that **Part 2 of the 4<sup>th</sup> schedule** of the Constitution of Kenya, explicitly provides for refuse removal, refuse dumps and solid waste disposal. The population in Trans Nzoia County is growing in the urban settlements leading to human activities that generate large quantities of solid waste;

**FURTHER AWARE** that the County Government does not have proper solid waste management system especially in Kitale town, Kiminini, Kachibora, Sibanga and Endebess urban centers leading to spillage of garbage in most parts of the streets.

**APPRECIATING** the use of Technology to recyclable bio-degradable and hazardous waste;

Accordingly, I intend to **MOVE** that this House Resolves that the County Government through the Department of Water, Environment, Natural resources and Climate Change;

1. Provide and label litter bins for recyclable waste and non-recyclable waste within major streets in Kitale town.
2. Install suitable facilities in every shopping centers across the county for temporary holding of waste/garbage awaiting weekly collection.
3. Prepare a legal frame work to punish people found littering or illegally dumping garbage within Tran-Nzoia County.
